

They are eligible for drawl of Basic Pay in higher level i.e.in Level-7 from the date of shouldering higher responsibilities as CTI. The date of assuming higher grade responsibilities by the employees should be advised to all concerned. They will be on probation for a period of 12 months and their continuance in the higher level will be subject to their successful completion of probation. The employee at Sl.No.1 is eligible for transfer benefits.

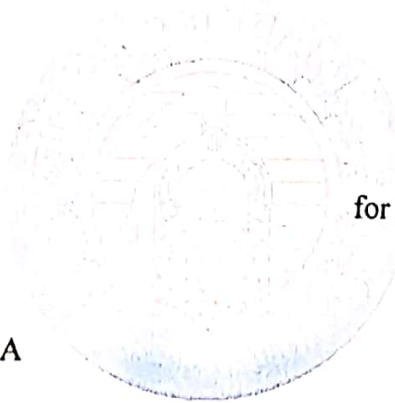


