The financial up-gradation under MACPS in favor of the employee is granted subject to following terms and conditions:

- 1. That there is no DAR/SPE/Vig. Cases pending /contemplated against her on the date of granting financial up-gradation under MACP Scheme. There will be no change in the designation, or the nature of duties performed. The status of the employee will remain unchanged. The financial up-gradation under the MACP Scheme shall be purely personal to the employee concerned and shall have no relevance to seniority position i.e., this will not confer on her for any seniority benefits.
- 2. The MACP envisages merely placement in the immediate next higher grade pay/Level in the hierarchy of the recommended revised Pay Band/Grade Pay and levels. Benefit of pay fixation available at the time of regular promotion shall also be allowed at the time of financial up-gradation under the scheme (PCPO/SC SC No.34/2020).
- 3. The Arrears/overpayment of pay and allowances if any involved shall be regulated accordingly.
