Retention of Railway quarters without prior permission will be treated as unauthorized occupation and shall be liable for recovery of damage rent and over the railway material, if any under their possession to their immediate supervisor.
- 5) The above-named employees should be relieved immediately within a week, without either unit waiting for the reliever to this office duly attesting photograph, LTI & specimen signature on relief letter for further relieving.
