The provisional list of eligible & ineligible for selection to the post of Jr.Clerk-cum-Typist in level-2 of 7th CPC Pay Matrix (erstwhile Group-D to Group-C) against 16 2/3% quota are prepared with the information provided by the candidates in their applications. The Eligible & Ineligible list for the subject selection is enclosed at Annexure-A & B respectively and can be accessed through website www.scr.indianrailways.gov.in -> About us -> Divisions -> Vijayawada -> Personnel Branch.

Further, it is also advised that:


1. At any point of selection process, if it is found that any candidate is NOT fulfilling the eligibility conditions mentioned in the notification, their candidature will be summarily debarred.
2. The date of written test is fixed to be conducted on 16.07.2023 (Sunday) and notified vide letter dated 19.06.2023. Accordingly, the candidates listed in the eligible list are alerted to readiness to attend written examination scheduled to be held as above. The time & venue of examination is 14:00 hrs at ETTC/STPM/BZA. Candidates are advised to report exam venue sharp by 13:30 hrs.
3. Syllabus for the examination was already communicated as mentioned in Para-4 of notification vide reference above. Candidates are also advised that the S.No. against their name may be treated as Roll Nos. wherever it is necessary.

It is the responsibility of concerned Supervisors that they should notify the same to the staff working under their control with clear acknowledgement and if any of them are on leave/sick/absent the contents may please be advised to their leave address. The employees may be relieved in time to enable them to attend the written examination without fail with proper relief letter from the Supervisors with photo identification.

The employees who report without any identification letters will not be allowed to appear for the written examination under any circumstances. The eligible employees may also be informed that 'No Supplementary written examination will be conducted' as the selection is held by calling volunteers and there is no provision for Supplementary test for whatsoever reasons.
