The financial up-gradation under MACPS in favour of the above employees are granted subject to the following conditions:

- 1. That there are no DAR/SPE / Vig. Cases pending /contemplated against them.
- 2. There will be no change in the designation or the nature of duties performed. The status of the employee will remain unchanged.
- 3. The financial up-gradation under the MACP Scheme shall be purely personal to the employees concerned and shall have no relevance to seniority position i.e. this will not confer on him any seniority benefits.
- 4. The MACP envisages merely placement in the immediate next higher grade pay/Level in the hierarchy of the recommended revised Pay Band/Grade Pay and levels (PCPO/SC's SC No. 34/2020).
- 5. Benefit of pay fixation available at the time of regular promotion shall also be allowed at the time of financial up-gradation under the scheme (PCPO/SC's SC No. 34/2020).
- 6. They can exercise option for fixation of pay under rule 1313 1(a)(i) from the date of accrual of increment in lower grade, so as to reach concerned cadre section within one month from the date of issue of this office order. The employees who exercise such option are only eligible to draw "pay with option" as mentioned against each name, otherwise their pay will be drawn as shown at "pay without option".
- 7. Arrears/Overpayment involved if any will be drawn/recovered accordingly.

The above fixation of pay on granting of MACP was certified by accounts vide Lr. No. A/E1/BZA/MACP/Comml.Staff, Dated. 03-06-2022 & Lr. No. A/EN/E1/2, Dated. 02/03-06-2022.
