

The above fixation on grant of financial up-gradation under MACPS has the certification of Sr.DFM/BZA vide Lr.No.A/E1/BZA/MACP/CTI dated.29.06.2021.

The financial up-gradation under MACPS in favour of the above said employees are granted subject to the following conditions.

1. The MACP envisages only placement in the next higher Grade Pay as per Section-I, Part-A of the First Schedule of the Railway Services (Revised Pay) Rules, 2008.
2. The financial up-gradation under the MACPS is purely personal to the employees to whom it is granted and shall have no relevant to their seniority position
3. The above employees shall retain their designation, status and duties.
4. They should be free from DAR/SPE/Vigilance cases on the date of grant of financial up gradation.
5. At the time of actual promotion if any in future, if it happens to be in a post carrying equal grade pay which is available under MACPS or more grade pay than what is available on regular basis, no pay fixation would be available and only difference of Grade Pay if due would be made available.
6. The above employees are eligible for financial and certain other benefits which are linked to the pay drawn by an employee such as HBA, allotment of Govt. accommodation etc.

The above employees can exercise option for fixation of pay on grant of 3rd MACP from the date of accrual of increment in lower grade under FR 22 1(a)(1) and such option should be submitted to this office within one month from the date of issue of this order.
