Their appointment is subject to the following terms and conditions: -

1. The appointment is purely temporary and services are liable for termination on 14 days notice without assigning any reasons.
2. They will be on probation for a period of two (2) years and their continuance in the higher level will be subject to their successful completion of probation.

3. They will be governed by the Indian Railway code/manual and conditions of services in force from time to time. Though their appointment and subsequent promotion normally on BZA division, they are likely to be transferred to anywhere on S.C.Rly in the exigencies of service
  4. They will be governed by the National Pension System
  5. Appointment in respect of SC/ST/OBC candidates is provisional and is subject to the cast certificate verified through the proper channel. If the verification reveals that the claim of the candidates belonging to the SC/ST/OBC community is false, their service will be terminated forthwith without assigning any further reasons and with prejudice to such further action as may be taken under the provision of the Indian penal code for the production of false certificate.
  6. The appointment is subject to the terms and conditions mentioned in the offer of appointment and instructions issued by the administration from time to time governing such appointments.
  7. The names are not arranged in the order of seniority. Their seniority will be fixed as per existing extant rules.
  8. The date of joining/independent charge should be advised to this office immediately without fail.
  9. . The above candidates will be taken on duty by concerned supervisors/Officers duly verifying their identification marks/ photographs /LTI and for identification of the employee a letter issued by this office through HRMS directing them for initial training shall be connected.
