The financial up-gradation under MACPS in favour of the above employees is granted subject to:-

1. That there are no DAR/SPE/Vig. Cases pending /contemplated against them on the date of granting financial up-gradation under MACP Scheme. There will be no

change in the designation, or the nature of duties performed. The status of the employee will remain unchanged. The financial up-gradation under the MACP Scheme shall be purely personal to the employee concerned and shall have no relevance to seniority position i.e., this will not confer on them for any seniority benefits.

2. The MACP envisages merely placement in the immediate next higher grade pay/Level in the hierarchy of the recommended revised Pay Band/Grade Pay and levels. Benefit of pay fixation available at the time of regular promotion shall also be allowed at the time of financial up-gradation under the scheme (PCPO/SC SC No.34/2020).
3. They can exercise option for fixation of pay under FR-22 from the date of accrual of increment lower grade, so as to reach concerned cadre section within one month from the date of issue of this office order. If, exercised such option, then only he is eligible to draw "pay with option" as mentioned above, otherwise his pay shall be drawn as shown at "pay without option". Arrears/OP if any involved may be drawn accordingly.

The above fixation of pay on grant of MACP has certification of **Sr.DFM/BZA vide letter No. AI/ENG/E-I dated 07.08.2024** and the same is subject to review whenever necessitated due to the clarification issued by the Nodal Ministry/Railway Board or Headquarters office on MACP Scheme.
