- They are being free from DAR/SPE/Vigilance cases, suspension and criminal investigations in terms of instruction contained vide PCPO/SC No.16/1993 and not undergoing any suspension and penalty debarring them from promotion.
- The final outcome of ongoing litigations/courts on the subject.
- Outcome of cases pending before various courts of law.
- If the employees do not carry out the promotion orders within 15 days, it will be deemed as be a refusal and will be dealt accordingly as per the instructions CPO/SC's letter No.P/R/ 585/VI dated 29.04.2006 and letter No.P/R/605/II dated 07.01.2008.
- They can exercise option for fixation of pay under FR-22-1(a)(i) from the date of accrual of lower grade increment and such option should be reached to this office within one month from the date of issue of this office order.
- Their further posting orders & pay fixations will be communicated from concerned cadres as per extent procedure.**

They are eligible to draw higher rate of pay from the date of shouldering higher responsibility as Office Superintendent in Level-6 of 7th CPC Pay Matrix. They will be on probation for a period of 12 months and their continuance in the higher grade will be subject their successful completion of probation in terms of PCPO/SC SC.No.175/2001.
