1. In terms of above referred Board's Corrigendum No.12 dated 11.10.2019 to Rates Master Circular/PCC/2019/0, and letter No.TCR/1394/2014/02 Pt dated 11.04.2020, Permissible Carrying Capacity (PCC) and Loading Tolerance of BOXN and BOXNHL wagons for loading of Pet Coke was notified w.e.f. 13.10.2019 & valid up to 11.10.2020 as under:

2. The issue has been reviewed and the Competent Authority has decided that the above notified Permissible Carrying Capacity (PCC) and Loading Tolerance for BOXN shall also be applicable forBOXNHS wagons as under:

Type of wagon	Excepted CC+6 Routes	Universalized CC+6 Routes	CC+8 Routes	Loading Tolerance
BOXNHS	63 Tonne (for Pet Coke)	63 Tonne (for Pet Coke)	63 Tonne (for Pet Coke)	1 Tonne

3. These instructions shall come into force with effect from 27.06.2020 and shall remain valid upto 11.10.2020.


