Ref:- (i) This office earlier restriction message No- T/239/Restriction/PT-II(.) dated 16.12.2019 .
 (ii) DOM(I/C)/LMG COIS message No-LD/OPTG/123/PARCEL . DATED 13.02.2020.(.)

Under reference (i) , restriction was imposed for handling of VPs for Piecemeal Demand , and lease except VPs for departmental ,Military /Govt, perishables and Live stock(pigs) to and from Guwahati (GHY) and Kamakhya (KYQ) station with effect from 19.12.2019 and upto 18.06.2020 for 06 (Six) months due to operational constraints at GHY and KYQ station .

Now it has been decided by competent authority to withdraw the restriction for handling of all types of piecemeal Demand and Lease VP at Guwahati (GHY) for a period of 06 months on trail basis with effect from 01.03.2020 to 31.08.2020 subject to the following conditions:-

1. The VP shall be attached to GHY terminating trains in rear most only.
2. VP shall be handled at GHY parcel siding only.
3. No shunting will be allowed at GHY for handling of VP at platform , as that would lead to loss of punctuality of other trains.
4. No VP shall be attached to 55801 (NBQ-GHY MANAS RHINO PASSENGER).

Kamakhya (KYQ) station shall remain restricted for handling of Demand And Lease VPs except VPs for departmental , military /govt , perishables and live stock(pigs) .
