The following orders are issued with the approval of Competent Authority.

- The Jr. Scale post of ACM/GNT& PO (PC: 11SC8P022) which was transferred to Headquarters for operation as ACM/Claims/HQrs in terms of this office order No.77/2023 dated 20.03.2023, is now restored for its original operation as ACM/GNT&PO (PC: 11SC8P022).

Sri K.Govinda Rao, CCI/SC/BO in Level-7 of Pay Matrix of SC Division who expressed his willingness and is medically found fit for Gr'B' (Non-Technical) with glasses vide CMS/SC's Certificate No.Group-B/16/23 dated 14.06.2023, is promoted to Gr'B' on adhoc basis and is posted as ACM/II/HYB (PC: 11SC7P007) against the post mentioned at SI.No.2 above.
- 10. Sri A.Srigirish, CCI/Sr.DCM/O/SC in Level-7 of Pay Matrix of SC Division who expressed his willingness and is medically found fit for Gr'B' (Non-Technical) with glasses vide CMS/SC's Certificate No.Group-B/13/2023 dated 14.06.2023, is promoted to Gr'B' on adhoc basis and is posted as ACM/Claims/HQrs (PC: 11SC7P007) against the post mentioned at Sl.No.3 above.

The pay of the employees on their adhoc promotion to Jr.Scale should be fixed in terms of Rule 1313(FR 22) I (a) (1), as amended vide ACS No.63 through RBE No.51/2019 (PCPO/SCR's Serial Circular No.49/2019). In case, if any of these employees are in Pay Level-8 and above due to grant of MACPS, no further fixation is allowed on their adhoc promotion as per extant instructions.

The promotions of the above employees at SI Nos. 6 to 10 are subject to the condition that:

- i) They are being free from DAR/Vig cases and that they are not presently undergoing any penalties that debars promotion.
 - ii) The adhoc promotion is purely temporary till the formation of regular Group'B' panel.
- iii) The adhoc promotion does not confer the employees any right of continuity, seniority or any other consequential benefits except those which are specifically allowed in terms of extant instructions. The adhoc arrangement can be terminated at any time without assigning any reasons there for.
- iv) Their continuation as adhoc ACM would be subject to their performance in the post and in case their performance is found to be unsatisfactory, they will be reverted back to their parent post without assigning any reasons there for.

The date the above changes take place should be advised to all concerned duly sending charge assumption/relinquishment reports and in triplicate to Dy.CPO/Gaz.
