The supervisory officials concerned should relieve them to the above mentioned stations immediately with photo identification letter affixing their specimen signature and LTI duly attested.

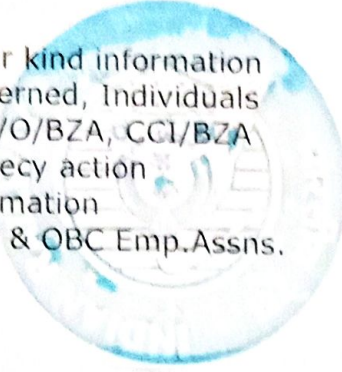
