They can exercise option for fixation of pay under FR-22 1(a)(1) from the date of accrual of lower grade increment and such option should be reached to this office within one month from the date of issue of this order.

The date of assuming higher responsibilities by the above employees should be advised to all concerned. They will be on probation for a period of 12 months and their continuance in the higher grade will be subject to their successful completion of probation.

All the employees mentioned under Para- III & IV should be relieved immediately to carry out transfer orders. The concerned supervisory officials are responsible to relieve the employees to carryout transfers. A copy of relief memo/joining report should be endorsed to commercial cadre section of this office without fail.

The employees transferred to out stations should vacate Railway Quarters if any, under their occupation and handover Railway property, if in possession before they are relieved.
