  - ii) They will continue to be governed by the provisions of the Indian Railway Codes & Manual and other extent orders as amended from time to time.
  - All Group 'C' and erstwhile Group 'C' posts in the RCT will be filled by serving Railway Employees in relevant grade/level with a minimum of two years regular service in that grade on transfer basis on a tenure of 05 years or till he/she is due for promotion in his/her parent cadre, whichever is later.
