
MEMORANDUM

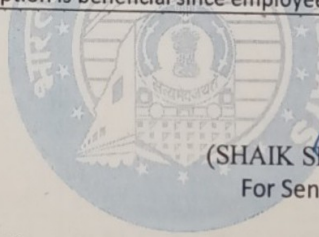
