PCSO/SCR has advised to launch a safety drive on Fire Preventive measures from  
04.02.2020 to 18.02.2020, involving officers and supervisors of Electrical/OP, Electrical/M,  
Electrical/TRD, Electrical/ELS, Commercial, Security, Mechanical & Optg. departments.  
During the drive period the following are the aspects to be checked:

- Provision of proper protection in electrical equipments including mobile / laptop charging point and associated electrical wiring provided in non Ac/Ac coaches.
- To check entry of unauthorized passenger / vendors in the coaches.
- Emergency feed of electric supply from the adjoining coaches should be made only in unavoidable circumstances and that too for a short period. It must be ensured that the connections for such emergency feed are properly secured. Also ensure checking of condition and firmness of emergency feed terminals, both during primary and secondary maintenance. Emergency feeding should be done with prescribed size of cables.
- Precaution to be taken in booking of contraband, explosives and inflammable goods as per commercial rules. In the drive, education of staff booking parcel/luggage is an important aspect.
- Intensive checks on the unauthorized carriage by passenger of inflammable explosive materials, gas cylinders, crackers and other items not allowed to be carried by them on trains.
- Random / surprise check by railway officials in co-ordination with GRP and RPF in trains and at stations of luggage and parcels for inflammable materials before loading in SLRs.
- Adequate and proper maintenance of electric devices in the coaches, locos, EMUs, special vehicles, MEMUs, DEMUs.
- Adequate fire suppression measures and their proper maintenance in the pantry cars. The staff including pantry car staff, contractor's staff should be trained for operating fire extinguishers.

On completion of the drive a detailed report on the number of checks conducted shortfalls/irregularities noticed and action taken may be sent to this office by 19.02.2020 for the appraisal of PCSO/SCR.
