

The above names are arranged in the order of **MERIT** as per S.C No. 95/2009 .The empanelment of the employees at S. No. 21 and 35 is considered against future reserved vacancies in terms of CPO/SC's Ir No. SCR/P-HQ/602/RP/Policy dt. 23.06.2017 and the employees at S.No. 50 , 51 and 52 are empanelled against reserved points (ST). There is a short fall of 01-ST vacancy due to non-availability of qualified employees as per rules.



In terms of Railway Board's letter no. 2018-E(SCT)/25/16 dt. 24.08.2020 & 17.08.2020, the policy of best amongst the failed is not applicable to the selection conducted for promotion from Group-D to C posts against 16 2/3 % LDCE quota. Therefore, the declaration of name of Sri K. Satyanarayan (ST) APM/KAPT as qualified in the written test under best among the failed policy in the declaration of results vide this office letter dt. 03.12.2021 is to be treated as erroneous. In view of Railway Board letters dt. 17.08.2020 and 24.08.2020 the suitability of Sri K.Satyanarayan (ST) is not adjudged.

The empanelment of the above employees is subject to the condition that they are free from SPE/VIG/DAR cases. If DAR proceedings are pending against the above employees, further action may be taken in terms of Serial Circular No. 16/1993 and in the light of subsequent clarifications issued, if any. While publishing the panel, it may be ensured that the CPO/SC's instructions contained in Para 3.4 of serial circular No.16/1993 is notified to all concerned in the panel.

The panel is final but remains as "Provisional " due to various cases pending before various Courts of LAW/CATs and also subject to outcome of main SLPs and contempt petition,© No. 314/2016 in SLP© No. 4831/2012.
