Sub: Selection to the ex-cadre post of Instructor (Commercial) Level-6 of 7th CPC Pay Matrix, at ZRTI/MLY.

Ref: PCPO/SC's Notification No.SCR/P-HQ/227/ EC/INST/Vol-IV dated 30.08.2022

Further to this office notification of even number dated 30.08.2022 cited, the names of employees found provisionally eligible for being called for written examination in connection with the above selection are listed as Annexure-A enclosed.

The staff shown in Annexure-A should be alerted to be in readiness to appear for the selection i.e., written examination. The syllabus for the above selection has already been advised vide this office notification dated 30.08.2022.

In terms of Railway Board's Lr.No.E(NG)I/2017/PM 1/11dated 13/05/2019 (RBE No.79/2019) the selection process is Written test (75 marks) and Classroom lecture trial (25 marks) . Maximum Marks -100 and Qualifying marks – 60 % . **There will be no Viva-voce.**

In terms of Railway Board's RBE No.04/2020 & RBE No.39/2020, the employees who qualified in the written test will be called for classroom trail and the Panel will be formed on the basis of merit.

In terms of Railway Board's Lr.No.E(NG)I/2018/PM14, dated 14/12/2018 (RBE No.196/2018) circulated as PCPO's S.C.No.212/2018, **the question paper will henceforth be 100% objective type.**

All questions will be of Objective Type. The examination will be in Pen and paper mode. To ensure authenticity of the answers, cuttings, over-writings, erasing or alterations of any type in the answer will not be accepted. Zero marks will be given for the answer having correction/overwriting. There shall be negative marks for incorrect answers. One third of the marks allotted for each question will be deducted for wrong answers

There will be **no Supplementary** Written examination.

No relaxation /reservation for SC/ST employees since this being an ex-cadre post. Panel will be drawn strictly as per over-all merit to the extent of vacancies notified.

They may be advised that no supplementary written examination for the absentees will be conducted under any circumstances since the selection is conducted by calling volunteers.

The venue and the date of written examination will be advised shortly. The Sample question booklet for written examination may be downloaded from official website of www.scr.indianrailways.gov.in (in Personnel Department Page). The questions in the sample question booklet are only indicative in nature. Actual question paper may contain questions not only from sample question booklet but also covering from the syllabus.
