(iii) Outcome of cases pending before Hon'ble Tribunals/ Hon'ble High Court/Hon'ble Supreme

(iv) The promotions in the merger category of Sr. Commercial -Cum -ticket Clerks in level-5 of pay matrix will follow as per the instructions of Railway Board communicated under RBE.No.59/2019.

The date of assuming higher grade responsibilities by the above employees should be advised to all concerned. They will be on probation for a period of 12 months and their continuance in the higher grade will be subject to their successful completion of probation.
