He is now posted as 'Sr. Commercial cum Ticket Clerk' in Level – 5 of the 7th PC pay matrix on Basic Pay Rs.29,200/- and posted to the stations as mentioned against below.

His appointment is subject to the following terms and conditions: -

- 1) The appointment is purely temporary and services are liable for termination on 14 days notice without assigning any reasons.
- 2) He will be on probation for a period of two (2) years and his continuance in the higher level will be subject to his successful completion of probation.
- 3) He will be governed by the Indian Railway code/manual and conditions of services in force from time to time. Though his appointment and subsequent promotion normally on BZA division, he is likely to be transferred to anywhere on S.C. Rly in the exigencies of service.
- 4) He will be governed by the National Pension System.
- 5) Appointment in respect of SC/ST/OBC candidates is provisional and is subject to the cast certificate verified through the proper channel. If the verification reveals that the claim of the candidates belonging to the SC/ST/OBC community is false, their service will be terminated forthwith without assigning any further reasons and with prejudice to such further action as may be taken under the provision of the Indian penal code for the production of false certificate.
- 6) The appointment is subject to the terms and conditions mentioned in the offer of appointment and instructions issued by The administration from time to time governing such appointments.
- 7) His seniority will be fixed as per existing extant rules.
- 8) The date of joining/independent charge should be advised to this office immediately without fail.
- 9) The above candidate will be taken on duty by concerned supervisors/Officers duly verifying his identification marks/ photographs /LTI and for identification of the employee a letter issued by this office through HRMS directing him for initial training shall be connected.

III) Sri. Pawan Kumar, PF. No. 24429808870, who was working as Sr. CCTC/BZA STN is transferred and posted as Sr.

CCTC/GENERAL SQD/BZA to work under control of CTI/GENERAL SQD/BZA on his existing pay and level on Administrative grounds. He should be relieved immediately to carry out transfer orders. The concerned supervisory officials are responsible for relieving the employee on time. A copy of the relief memo/joining report should be endorsed by all concerned officials without fail. The employee transferred to outstations should vacate Railway Quarters if any, under his occupation and hand over Railway property, if any under his possession to the concerned supervisory officials before he is relieved.
