Sub: **Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD)**

Ref: Board's letter of even number dated 22.04.2020 (Rates Circular No.8 of 2020) and Corrigendum thereto.

- 1.0 In terms of Board's letter under reference, revised policy guidelines for Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty flow Directions was issued.
- 2.0 The matter has been reviewed. Sanction of Competent Authority is hereby accorded to modify the 'Minimum number of wagons in a rake' in case of BCN/BCNA/BCNAHS and BCNHL wagons as 10 wagons for movement under TEFD Policy. Accordingly, Para 1.11(ii) of Rates Circular No.8 of 2020, may be modified as per the following:

1.11(ii): The minimum offer of traffic of the permitted stock shall be as under:


Wagons	Minimum number of wagons in a rake
BCN/BCNA/BCNAHS	10
BCNHL	10
BOXN Group	29
BOST	22
BRN	21
Mixed Rakes: BOXN+BRN Group/BOST/BFNS	20 (Minimum 5 of each type and maximum 10 of BOXN wagons)

- 3.0 Zonal Railways are advised that in case of BCN/BCNA/BCNAHS and BCNHL wagons, full rake will be placed and minimum 10 wagons or more will be loaded for availing benefit under the TEFD policy.
- 4.0 All other terms and conditions stipulated in the policy continue to apply unchanged.

- 5.0 These instruction will come into force w.e.f. 20.08.2020 and will remain valid till 31.03.2021.




