

They are eligible for drawl of Basic Pay in higher level i.e.in Level-6 from the date of shouldering higher responsibilities as TTI. The date of assuming higher grade responsibilities by the employees should be advised to all concerned. They will be on probation for a period of 12 months and their continuance in the higher level will be subject to their successful completion of probation. The employees at Sl.No.3,5,8,15 & 33 are eligible for transfer benefits. The above employees can exercise option for fixation of pay under FR 22 I(a)(1) from the date of accrual of next increment in lower grade and such option should be submitted to this office within one month from the date of issue of this office order.

The above promotions are provisional and subject to the condition that;

- a) the employees in this Office Order are free from DAR/SPE/Vigilance cases.
- b) final outcome of ongoing litigations/court cases on the subject and other court cases, if any, pending before various courts of law.
