In regard to above subject, Sri K.Venkateswarlu, TTI/AK in Level-6/GP Rs.4200 in Commercial Department on NED Division was transferred on existing pay and level and posted on NED Division along with post on administrative grounds, vide this office order under reference(iii).

The above employee was imposed with the penalty of "Removal from Service", vide Sr.DCM/NED's Memorandum No.N/CM/C/KV/13.V, dt.17.12.2014. Later, Sri K.Venkateswarlu, TTI/AK in Level-6/GP Rs.4200 was reinstated into service as Ticket Examiner in Level-2/GP Rs.1900 for a period of five years with cumulative effect with loss of seniority duly fixing his pay Rs.7730 and posted to AKOLA, vide this Office Order No.158/2015, dt.09.06.2015. The above penalty has completed.

The above employee has submitted a representation under reference(iv) and requested for promotion to the post of Chief Ticket Inspector in Level-7/GP Rs.4600.

However, the lien and seniority of the above employee is maintained on BZA Division.

In view of the above, it is requested to process for promotion of the above employee to the post of Chief Ticket Inspector in Level-7/GP Rs.4600 and advise this office duly transferring one post of Chief Ticket Inspector in Level-7/GP Rs.4600 from BZA Division to NED Division. The above employee is normally going to retire on 31.07.2021 on his superannuation.
