The above up-gradations is provisional and subject to:-

- The employee who is already granted Financial up-gradation in higher level under MACP Scheme is not eligible for fixation of pay in above up-gradation.
- There shall be no change in the classification/nomenclature/designation/duties/responsibilities after up-gradation.
- She is being free from DAR/SPE/Vigilance cases, suspension and criminal investigations in terms of instruction contained vide PCPO/SC No.16/1993 and not undergoing any suspension and penalty debarring her from up-gradation.
- The final outcome of ongoing litigations/court cases on the subject.
- Outcome of cases pending before various courts of law.
- She can exercise option for fixation of pay under FR-22-1(a)(i) from the date of accrual of lower grade increment and such option should be reached to this office within one month from the date of issue of this office order.

She is eligible to draw higher rate of pay from the date of assuming charge as Chief Office Superintendent in level-8 of VII CPC Pay Matrix.
