The above up-gradations are provisional and subject to:


- 1) There shall be no change in the classification/nomenclature/Designation/duties/responsibilities after up-gradation.
- 2) The employees who were already granted financial up-gradation in higher level under MACP scheme are not eligible for fixation of pay in above up-gradation
- 3) They are being free from DAR/SPE/Vigilance cases, suspension and criminal investigations in terms of instruction contained vide PCPO/SC No.16/1993 and not undergoing any suspension and penalty debaring them from promotion.
- 4) The final outcome of ongoing litigations/courts on the subject
- 5) Outcome of cases pending before various courts of law
- 6) The up-gradation of above employees is provisional and shall be subject to the outcome of the main SLPs and contempt petition (C) No.314/2016 in SLP (C) No.4831/2012 – Samata Andolan Samiti through president Vs.Sanjay Kothari & Others, and any other cases pending in other courts on the above subject.
- 7) Their pay fixation will follow

8) They are eligible to draw higher rate of pay from the cutoff date i.e.01.12.2022 as CTI in level -8 of 7th CPC Pay Matrix.

9) S.No. 82, 83, 84, 85, 86, 87, 88 & 89 are eligible to draw higher rate of pay as CTI in level - 8 of pay matrix from the dates mentioned against each.
