The above up-gradations are provisional and subject to:-

- The employees who were already granted Financial up-gradation in higher level under MACP scheme are not eligible for fixation of pay in above up-gradation.
- They are being free from DAR/SPE/Vigilance cases, suspension and criminal investigations in terms of instruction contained vide PCPO/SC No.16/1993 and not undergoing any suspension and penalty debarring them from promotion.
- The final outcome of ongoing litigations/courts on the subject.
- Outcome of cases pending before various courts of law.
- The up-gradation of above employees is provisional and shall be subject to the outcome of the main SLPs and contempt petition (C) No.314/2016 in SLP (C) No.4831/2012 – Samata Andolan Samiti through president Vs. Sanjay Kothari & Others, and any other cases pending in other courts on the above subject.
- The eligible employees can exercise option for fixation of pay under FR-22-1(a)(i) from the date of accrual of lower grade increment and such option should be reached to this office within one month from the date of issue of this office order.
- Their pay fixation will follow.
