Registrar/RCT/AMVT Bench/GNT's letter 2<sup>nd</sup> cited to effect his promotion as RS-II in level-6 of pay matrix.

Being relieved by Addl. Registrar/RCT/AMVT/Bench/GNT on 31.03.2022 (A.N) he reported this office on 01.04.2022 for further posting orders on this Division. Accordingly he is now promoted as Reservation Supervisor-II in level-6 of pay matrix and posted at MTM against vacancy on his repatriation/promotion on his same pay in the same level-6 in the pay matrix as he was already granted MACP in level-6. He is relieved today i.e. on 11.04.2022 (F.N) with instructions to report to SS/MTM immediately. The period from 01.04.2022 to 11.04.2022 (F.N) is treated as waiting for orders in this office.

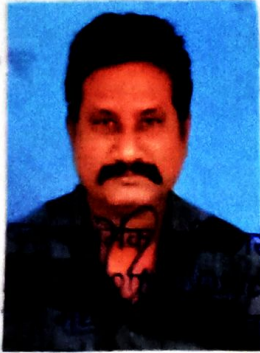
The above promotion is provisional and subject to the condition that:
