The employees mentioned above are eligible for fixation of pay in higher level and can opt for fixation of pay within one month from the date of issue of this order in terms of Board's instructions circulated through CPO/SC SC No.138/1981. But, those who were already benefitted with financial up gradation into Level-06 in 7th CPC under MACPS are not eligible for fixation of pay again on promotion in terms of CPO/SC's Serial Circular No.85/2009.

The above promotions are subject to final outcome of cases pending if any before Hon'ble CAT/High Court/Supreme Court,.
