

MEMORANDUM

Sub: Redeployment of Surplus Teachers (TGT in Level-7) as Ch.OS in Level-7 to the accepting departments in Ministerial cadre.

Ref: PCPO/SC's Lr.No.SCR/P-HQ/695/E-Sch/Corres dtd.31.03.2021.

PCPO, vide letter dtd.31.03.2021 cited, has advised to maintain the surplus Teachers in Level-7 as ChOS in the cadre in a separate pool of supernumerary posts without interfering with the ministerial cadre of the concerned departments and to extend all the benefits on par with ministerial staff as per extant rules.


